 - Individuals:
 - i. Exploring/Experimenting (microgrants) up to \$2500
 - ii. Emerging Artists (new or growing art practice, under 5 years of experience) up to \$10,000
 - iii. Established Artists (seasoned art practice, over 5 years of experience) up to \$7500
 - Organizations
 - i. Supporting Emerging Artists
 - ii. Supporting Established Artists
- 3. Shift to paid reviewers
- 4. Change the name from Artists @ Large to Peer Reviewers
- 5. Collect data and ensure the data is shared be more transparent
- 6. Move forward with recruiting board members
- 7. Move forward with forming community connections

L. Golds noted the change to a paid review panel will allow for Board members to provide more support to potential applicants.

L. Golds will Chair the grant review meeting when all applications will be reviewed by the Peer Review panel, and the slate of recommended Spring 2023 Arts Fund grants will then be approved by the Board at a subsequent meeting.

L. Golds said the Executive recommend that the Arts Fund Board continue to work with Jenn Chan to work through the application questions, guidelines, and policies to ensure that they are reviewed and revised.

The Board discussed options regarding anti-racism training.
