

Waterloo Region Arts Fund Minutes June 15, 2023, 3:00 pm Meeting held electronically 150 Frederick Street, Kitchener, Ontario

1. Call to Order

Lindsay Golds, Co-Chair, commenced the meeting by calling it to order, and the Board members proceeded to introduce themselves to Raechele Lovell, the newest member of the Board of Directors.

5. New Business

5.1 New Board Member

L. Golds addressed the Flash Waterloo Region donation, which amounted to \$3,784.64, to the Region of Waterloo Arts Fund to support a photography grant. She informed the attendees that a photography grant had been carefully selected, and the funds would be directed towards this successful grant.

L. Golds initiated a discussion regarding the recommendation. Board members engaged in conversation exploring next steps, potential challenges, and potential implications for the art community.

R. Lovell expressed her enthusiasm and readiness to be a part of the board, assuring that there are sufficient board members for a smooth transition. She also highlighted the eagerness of the group of artistic leaders she's assembling to take on board responsibilities.

The current board members welcomed her to the Region of Waterloo Arts Fund.
